Geography:

Saint Johnsbury, also known locally as St. J., is the shire town (county seat) of Caledonia County, and the largest town, by population, in the Northeast Kingdom (NEK). St. Johnsbury is approximately 48 miles south of the Canadian border and 10 miles northwest of the Connecticut River which forms the border between Vermont and New Hampshire. Two of Vermont's three interstate highways meet just south of St. Johnsbury, with Route 91 intersecting Route 93 at its northern terminus. Routes 2 and 5 also lead into St. Johnsbury from the West and South of the state, respectively. These highways provide transportation for travel and commerce within the region, and help make St. Johnsbury an economic hub in the NEK.

A brief History:

Originally granted as part of New Hampshire in 1760, the town was re-granted by Vermont in 1786 under the name of Dunmore. The name was changed in 1790 to St. Johnsbury.

The 1800s and early 1900s brought great manufacturing growth to the town. A railroad was built during the mid-1850s, connecting St. Johnsbury to markets from Montreal to Boston, and for a while, St. Johnsbury was known internationally for three major products: measuring scales, maple syrup candy, and bowling candlepins. Dozens of passenger trains passed through the town daily, and there was a vibrant community of mill and industrial workers as well as a thriving commercial district.

Fairbanks Scales was the largest scale-making company in the world in the 1940s. While the finance, marketing, and executive offices have been moved to Missouri, the company still operates a manufacturing plant in St. Johnsbury, and the Fairbanks family legacy is still felt in the town through the St. Johnsbury Academy, a private high school founded by the Fairbanks family in 1842, and the Fairbanks Museum and Planetarium, founded in 1889 and home to VPR's Eye on the Sky and Vermont's only public planetarium.

Maple Grove Farms, the largest pure maple syrup packer in the United States and largest manufacturer of Maple Candies in the world was founded in 1915 and is still based in St. Johnsbury.

St. Johnsbury served as a regional rail hub until as late as the mid 1990's when extensive flooding ended use of the rail lines served by St. J. The old Canadian Pacific railroad depot, a part of the St. J. rail yard built during the late 1800s, is currently used by the Rural Community Transportation system and other businesses. The rail lines feeding into St. J. are currently being converted into the Lamoille Valley Rail Trail. This endeavor will create the most extensive recreational trail network in New England by connecting St. J. to Swanton, VT via converted rail line.










St Johnsbury Labor Force, 2011 Inflow/Outflow (All Jobs):
