Chief Executive Officer of Vermont's only research university, a Land and Sea Grant College comprising nine degree-granting colleges and schools (Agriculture and Life Sciences, Arts and Sciences, the Grossman School of Business Administration, Education and Social Services, Engineering and Mathematical Sciences, Graduate College, the Larner College of Medicine, Nursing and Health Sciences, and the Rubenstein School of Environment and Natural Resources), the Honors College, UVM Libraries, UVM Extension, the UVM Agricultural Experiment Station, and Continuing Education.

Accomplishments 2002-2011 include an increase in undergraduate applications from 9,776 for fall 2002 to more than 22,000 for fall 2011 (recent incoming classes characterized by record academic quality indicators and diversity); creation of the Honors College, of a growing system of undergraduate residential living/learning communities, and of the Center for Clinical and Translational Science, the Vermont Advanced Computing Center, and the Vermont Center for Emerging Technologies; a 66% increase in enrollment in Ph.D. programs and record levels of research funding (of the 70 Carnegie research universities with 15,000 or fewer students, UVM is one of only three publics to rank in the top 20 in research expenditures); leadership of the successful Campaign for the University of Vermont (exceeded the \$250 million goal by more than \$28 million); co-founder and inaugural director of the University of Vermont Foundation; support of negotiated faculty contracts that achieved, among other things, annual salary pools averaging slightly above 5% per year for nine straight years; significant campus expansion (by 1.2 million square feet, or 27%), including major land acquisitions and new academic buildings, residence halls, and a new student union (all LEED Certified at the Gold level); enhanced intellectual life of the campus with new lecture series (Burack Lecture Series) and a non-resident faculty program (James Marsh Professors-at-Large); invigorated intercollegiate athletics with nationally competitive teams and annual academic cup awards in conference (seven years running). Increased directed federal appropriations from 154th nationally among colleges and universities in 2003 to 20th in 2007. Enhanced national presence and visibility

of UVM by establishing a voice through opinion pieces in the national press and media (the *Washington Post*, the *Chicago Tribune*, National Public Radio, the *PBS Newshour with Jim Lehrer*), keynote addresses at national and regional professional meetings, and leadership positions in national and regional associations. University was named in top ten of "up-and-coming national universities" (public and private) by *U.S. News and World Report* in August, 2009. Undergraduate class graduating in May 2010 had highest six-year graduation rate in institutional history, 76.3% overall and 80.4% for Vermont students. Received a highly favorable fifth-year review from the Board of Trustees, conducted with the assistance of Association of Governing Boards consultant Robert Atwell. Named Vermonter of the Year for 2007 by the *Burlington Free Press*, January 1, 2008. Received the Richard A. Snelling Economic Development Award, December 2008.

Executive Vice Chancellor and Provost, Louisiana State University (LSU), 1997-2002
