Two qualifying shows are available for 4-H members who are trying to qualify for Eastern States. **All current 4-H Working Steer project members who want to come and show their steers are also welcome to participate.** The shows are open to any 4-H member with a team listed on a 4-H Approval Form. Approval Forms, Lease/Loans (if applicable) and Animal Health Forms will be checked as animals are unloaded.

Follow signs to Route 14 in Sharon, Vt. Go across the green iron bridge which is across from Tracy's Midway Station. Turn right off the bridge then take the first left onto Howe Hill Road. Look for Allen Hill Road which will be on the right. Watch for the 4-H signs. Stay on Allen Hill Road for two miles, then turn left onto Skyline Drive. Look for the first place on the right with white fencing and a red arena.

#### **Details**

- Participants should call the show contact to sign up.
- Show times are 10:00 a.m. to 4:00 p.m. (approximate, depends on number of participants).
- Open to 4-H members ages 8 to 18 as of January 1, 2024.
- Bring lunch, snacks and beverages. We will be having a potluck lunch at this event.

#### **Show Classes**

The three events at each show are **Fitting and Showing**, **Cart Class** and **Stone Boat**.

Teamsters may choose which classes they would like to compete in. If they are participating to qualify for Eastern States Exposition, they must compete in all three events at each show and follow all standards and guidelines.

Ribbons will be awarded at the show according to the judge's discretion.

## Fitting and Showing

Teamsters will be judged on the condition of the steers and the manner in which they are presented to the judge. Judges will consider the following: Condition, cleanliness and grooming of steers; teamster's appearance and knowledge of working steers; and driving of the steers.



#### **Cart Class**

Teamsters will be judged on their ability to maneuver a two-wheeled cart through a series of obstacles. The judge will determine the course and set the time limit for hitching and completing the course.



#### **Stone Boat**

Teamsters will be judged on their ability to work a stone boat. The judge will determine the course and set the time limits for hitching and completing the course. The course will include at least one turn to the gee and one turn to the haw. Teamsters may elect not to pull the required weight for their division.
