2024 Vermont Master Composter Course

A noncredit Extension course offered by the University of Vermont Extension Community Horticulture Program in collaboration with the Vermont Agency of Natural Resources.

Course Syllabus

Course Description

The Vermont Master Composter course offers an in-depth study of backyard composting. Students learn the science and practice of effectively turning food scraps and yard trimmings into compost for use in home, school, and community composting settings. Although the science covered in this course applies to a range of composting systems, this course is intended for small-scale, noncommercial compost systems and does **not** cover municipal waste systems, farm-scale compost operations, mortality, or humanure composting. The course is offered online at <u>campus.extension.org</u> where students work weekly through eight modules that contain course materials, pre-recorded lectures, homework assignments, and online course discussions.

Students participate in the course in one of two tracks offered:

Track 1 is our volunteer certification track, meant for students who'd like to become certified Vermont Master Composter volunteers who give back to their communities with composting education and support. In this Track, students complete volunteer requirements, participate in weekly real-time Zoom sessions with instructors, learn about becoming a Vermont Master Composter volunteer, and participate in an in-person workshop(s) to see composting systems in action. Successful graduates of Track 1 receive a Vermont Backyard Composter certificate of course completion and, upon the completion of a ten-hour volunteer service commitment, earn a Vermont Master Composter certificate and title.

Track 2 is our learn-at-your-own-pace track offered to Vermonters who are not interested in or available to participate in a volunteer commitment. This track is also available to participants who live outside Vermont. Students have access to all course content (including recordings of lectures and discussion sessions) and are able to navigate the course at their leisure. Successful graduates of Track 2 receive a Vermont Backyard Composter certificate of course completion.

Meeting Times & Location

The online course portal opens on Friday, August 30, 2024 and closes on November 8, 2024. Each of the eight course modules opens weekly on Fridays at 5 p.m. ET. Track 1 (volunteer certification track) students meet via Zoom on Thursday evenings from 6 to 7:30 p.m. ET from September 5 to October 24, 2024. Track 1 students will receive the Zoom link for our weekly course meetings when the course opens.

Required Course Materials and Software

Required Course Materials

The course uses two required texts; both of which are included in the cost of the course and are available online as PDFs within the course portal:

- The Vermont Master Composter Resource Manual
- NYC Master Composter Manual

Students will view pre-recorded class lectures available online, complete assigned readings, submit weekly questions, and take quizzes and a final exam to successfully complete the course. All course modules also offer optional supplementary resources for further education on each topic addressed.

Course Learning Objectives

After completing this course, all students will be able to:

- Use UVM Extension, Master Gardener/Composter, the Extension Foundation's Campus, Zoom and other online resources for learning;
- Articulate the benefits of composting;
- Apply the principles of composting to create and manage an active compost system;
- Articulate the goals of Vermont's Act 148;
- Understand the basic properties of soil and the decomposition process; and
- Understand compost site design and manage a compost site.

In addition, Track 1 (volunteer certification track) students will:

- Be able to perform research on compost questions using University and other sources of research-based information to diagnose compost problems and provide management recommendations;
- Know the steps to create compost-related learning environments in local communities with other Vermont Master Composter and/or Extension Master Gardener volunteers; and
- Be able to articulate the mission of the UVM Extension Master Gardener/Composter Program, including the roles and responsibilities of Master Composter volunteers and program staff.

Refund Policy

The final date to drop out of the course and request a refund is Friday, Sept. 13, 2024 by midnight. Refund requests must be made in writing (email to debra.heleba@uvm.edu). We are not able to provide course refunds after this date for any students (Track 1 or Track 2). However, Track 1 students may switch over to Track 2

upon written request to Deb to complete the course at your own pace and receive a certificate of course completion.

Student Expectations

The Vermont Master Composter course is an 8-week commitment. To be successful, we expect students to commit the time it takes to watch the weekly lectures, do the weekly readings, take the weekly quizzes, and complete all assignments on time. We estimate that Track 1 students devote about 4 hours per week to successfully complete the course and Track 2 students may spend 2 to 4 hours each week to watch recorded sessions and complete the guizzes and final.

Expectations of Track 1 (Volunteer Certification) Students:

Course grades are heavily dependent on our students' abilities to complete assignments on time. We know that our students lead busy lives and have accounted in our grading for a few missed assignments that may crop up during the course; however, repeated absences or skipped assignments will likely result in poor course performance and an inability to proceed with program participation. Therefore, Track 1 students should:

- Commit to completing all course assignments on time, including weekly readings, pre-recorded lectures, weekly quizzes (due Fridays by midnight), final exam, and pre- and post-course surveys.
- Submit weekly questions based on the lectures and reading assignments for the instructors by no later than midnight on Tuesdays.
- Attend weekly Zoom sessions on Thursdays, 6 to 7:30 p.m.
- Attend at least one in-person workshop on selected Saturdays, 1 to 3 p.m.

In addition, Track 1 students must:

- Complete volunteerism paperwork during the first week of the course: Volunteer Application, a
 background check consent form (if you have lived in Vermont for more than a year) or fingerprinting
 process (if you have lived in Vermont for less than a year); and our Minor Protection Training. Failure to
 complete the volunteerism paperwork on time jeopardizes your Track 1 status and you will be asked to
 move to Track 2 to complete the course.
- Upon successfully completing the course, Track 1 students participate in a 10-hour volunteer internship (over 2 years). The purpose of the internship is to gain volunteer experience after the course by working under the mentorship of Master Composter volunteers. All volunteer hours to become a Certified Master Composter must be conducted at approved projects or on approved volunteer activities. Track 1 students should carefully assess their capacity to complete the 10-hour internship to become a Certified Master Composter volunteer. Vermont Master Composter volunteers are considered representatives of the University of Vermont and share research-based composting information with Vermonters through public presentations; tabling and displays at fairs, farmers' markets and other outlets; and/or assisting with Master Composter-approved community projects.

Expectations of Track 2 (At-Your-Own-Pace) Students:

 If interested in a Backyard Composter Certificate, Track 2 students must complete the pre- and postcourse surveys, course quizzes, and final exam before the course closes. Track 2 students have access to all course materials on the site, including lectures, recordings of weekly Q&A sessions, reading assignments, and other resources. If you complete all quizzes and the final exam by November 16, you will receive a Backyard Composters certificate of course completion.

Behavior Expectations

By participating in the course, you agree to abide by the University of Vermont's Our Common Ground:

- **Respect.** We respect each other. We listen to each other, encourage each other and care about each other. We are strengthened by our diverse perspectives.
- Integrity. We value fairness, honest conduct, adherence to the facts, and sincerity.

You may be asked to leave the course if your behavior:

- Poses a threat to the health or safety of participants or others;
- Threatens to disrupt the offering;
- May seriously diminish the experience of others; or
- For other sufficient reason.

The program coordinator will seek to engage with you if concerns arise about your behavior and provide an opportunity for you to correct it. Should concerns persist, the coordinator has complete discretion to ask you to leave or discontinue your participation in the program. There is no refund if you are dismissed.

Course Communication

Course communications occur in a couple of ways. We use discussion boards/forums for class reminders and for course discussions. Posts to these discussions boards automatically send emails to all students, so you should receive course notifications via email. For questions about the course, you can reach out to Deb anytime through direct messaging on the course site. To do so, click on the message block, and find and click on Deb's name and select "message" (this is a private, one-on-one communication). You may also email her at debra.heleba@uvm.edu.

Note: If you do not wish to receive forum emails, you can unsubscribe by clicking "unsubscribe" at the bottom of the email. You can also set the emails to digest mode to receive just one email daily. If you unsubscribe, please be sure to check the discussion board/forum on the course site regularly to keep up to date.

Upon successful completion of the course, Track 1 students are added to our Vermont Master Composter volunteer listserv and newsletter list to receive notifications about volunteer opportunities and other program news. Your email is also shared with volunteer leaders so they can introduce you to other volunteers and project opportunities. You may choose to opt-out of these communications upon request.

Grading Criteria & Policies

This course uses a points system for grading. Track 1 students must receive at least 102 out of a total 120 points (85% or higher) to pass the course and Track students must receive at least 44 out of a total 55 points (80% or higher) to pass.

We completely understand that extenuating circumstances occur (life happens!) which is why we have constructed grading this way, allowing you to miss a few assignments should something happen during the course. Please carefully assess your ability to meet the requirements of the course and keep up with the weekly assignments; we cannot accept late submissions.

Track 1 (volunteer certification). To pass the course, Track 1 students must receive a score of 85% or higher for the course. That means you must achieve at least 102 out of a total 120 points as follows.

Track 2 students. To pass the course, Track 2 students must achieve a score of 80% or higher to pass the course. That means you must receive at least 44 out of a total of 55 points by the close of the course on midnight on November 16 as follows.

Pre-Course & Post Course Surveys. All students are expected to complete a survey at the beginning of the course as well as a survey at the end (5 points per survey). The survey responses are confidential and results are used to improve the course. Completion of each survey will be used in calculating your grade.

Quizzes. The course uses weekly quizzes (5 points each); they are open-book, multiple-choice questions. You can take each quiz twice with your highest score used in calculating your grade.

Final Exam. There is a 20-question final exam at the end of the course worth 20 points of your grade. The exam is open-book and multiple choice, and you may take it two times if necessary. Your highest score will be used in calculating your grade.

Weekly Instructor Questions. To help solidify your learning each week, we require that Track 1 students submit a weekly question based on the lecture and readings. Selected questions are submitted to the instructor who addresses them in our weekly Zoom meetings. Questions are due each week on Tuesdays by midnight. Submission of weekly questions count for 4 points each week (2 points for Week 1) and will be used in calculating your grade. Although completely optional, Track 2 may submit weekly questions by midnight on Tuesdays too.

Weekly Zoom Meetings. Track 1 students are required to attend the real-time Zoom meetings on Thursdays from 6 to 7:30 p.m. ET to meet with instructors (3 points each week). The sessions are recorded and posted on the course portal; recordings may be accessed by all students. If students do not participate in at least 60 minutes of Zoom meetings, they will be marked absent. Track 2 students do not attend the real-time meetings but may view the recordings.

In-Person Sessions. Track 1 students are required to participate in at least one of three in-person workshop sessions facilitated by Natasha Duarte. Students are encouraged but not required to attend more than one session to view different composting systems. Track 2 students will be invited to attend these sessions only if space is available. The agenda is the same for all locations at sites in Ludlow, Montpelier and St. Albans. Each session is offered on Saturdays from 1 to 3 pm – final dates/locations will be posted to the course portal. If you cannot attend due to an extenuating emergency or medical circumstance, please notify Deb ASAP.

Late Work. Please carefully review the list of weekly assignments with their deadlines. Plan to access the course site weekly and scan your email for reminders. Due to the volume of students enrolled in the course, late or missed assignments will **not** be accepted. This is a firm policy, please do not ask for late or extra credit.

Volunteer Requirements. In addition to the above, Track 1 students must also complete our program's volunteer requirements (volunteer application, background check consent form or fingerprinting, and minor protection training) by the deadline to continue as a Track 1 (volunteer certification) student. Missing these assignments means you cannot continue as a Track 1 student and will be moved to Track 2.

Recording Class Sessions and Photography

Our Track 1 class discussion sessions will be audio-visually recorded for student reference and for students who are unable to attend live. Students who participate with their camera engaged or utilize a profile image are agreeing to have their video or image recorded. If you are unwilling to consent to have your profile or video image recorded, be sure to keep your camera off and do not use a profile image. Likewise, students who unmute during class and participate orally are agreeing to have their voices recorded. If you are not willing to consent to have your voice recorded during class, you will need to keep your mute button activated and communicate exclusively using the chat feature, which allows students to type questions and comments live.

Additionally, Track 1 students are required to attend in-person workshops where photographs are taken for program education and marketing purposes. Students must notify the course coordinator if they do not agree to allow UVM to photograph them. Otherwise, it is assumed that students agree with UVM capturing images in which they are visibly recognizable or identified and waive all rights that they may have to any claims for payment or royalties in connection with their participation in the course.

Course Outline / Weekly Schedule

This is a hybrid online course requiring both asynchronous (on your own) work and live weekly Zoom course discussions for Track 1 (volunteer certification) students. Over the course of the eight weeks, here's what you can expect.

Each new module opens on Fridays at 5:00 pm ET, starting on August 30. Interaction among students is encouraged and occurs on forums organized within the course platform.

Each week, Track 1 students are required to do the following:

- 1. Watch a pre-recorded lecture between Friday night and Tuesday night.
- 2. Do the reading between Friday night and Tuesday night.
- 3. Post your weekly question for the instructor about the lecture and/or reading by no later than Tuesday at 11:59 pm.
- 4. *Attend the live course discussion session on Zoom each Thursday night from 6 to 7:30 pm ET. (*Only Track 1 students attend the live course discussions; Track 2 students have access to the recordings).
- 5. Complete the weekly 5-question quiz no later than each Friday at 11:59 pm ET.

Track 2 (at your own pace) students navigate the course at their own speed and complete the course (including quizzes and surveys) by November 16. Track 2 students do not participate in the live weekly Zoom course discussions but do interact with fellow students within the online course platform through discussion forums and do have access to all recorded sessions.

2024 Weekly Schedule

The schedule for the 2024 schedule is as follows. Modules covered during weeks 6 and 7 are subject to change based on instructor availability – advanced notice will be given if changes occur.

Week 1: Course Introduction. August 30-September 6, 2024

We'll start the course by getting to know one another through virtual introductions. Deb Heleba will provide an introduction and answer any logistical questions you may have about the course and volunteering for the program. This week, you will take time to familiarize yourself with the navigation features of the course, learn how to ask questions, and locate where to read and post announcements. Track 1 students will complete program volunteerism requirements.

This week, you will learn about the history and environmental benefits of composting from Dr. Wendy Sue Harper. You will also learn about the five main factors most important in the composting process and will review various compost systems. Composting tools and how to troubleshoot issues will also be covered.

Week 3: Soil Ecology. September 13-19

Dr. Wendy Sue Harper will teach you about the properties of soil and how decomposition works. She will also cover the ecology and biology of soils and decomposition, and the effects of compost on soil fertility.

covers starting a community compost site, site design, harvesting, screening, and managing a community composting project.
