Vinyl Maintenance Instructions

INITIAL CLEAN-UP

Initial clean up involves removing installation adhesive and layout marks. This is normally accomplished by using a solvent such as mineral spirits, naphtha, Sovesso or the adhesive manufacturer's recommendation. Care must be taken to use clean white rags to avoid re-depositing adhesive in hair cell pattern. If initial clean up is not done properly, the seams or other areas will develop discolored areas at a later date. (see "previous cleaning residue" below) These areas should be rinsed thoroughly with clean water.

SPOT CLEANING

Spot surface normally involves tough marks or stains due to spills, graffiti, heel marks and impact from carts or trucks. These marks require a cleaner such as "Crown Anti-Vandal Spray" or "DWR2". These are specialized spot cleaners that should be used for small areas only. A short stiff bristled brush may be necessary to remove some stains from the hair cell surface. These cleaners should be rinsed thoroughly with clean water. So heel marks or abrasions from rubber bumpers on carts may be removed simply by brushing without a cleaner.

ROUTINE MAINTENANCE

General Routine maintenance should require nothing more than a commercially available liquid type cleaner (409, Fantastic, Pine-Sol, White Cap, Mr. Clean, etc.) to remove general pedestrian traffic dirt. Powdered type cleaners are not recommended because they tend to leave a residue if not rinsed properly. A sponge or a clean rag is usually all that is required, although some tough spots or large areas are cleaned easier with either a manual or mechanical scrubbing brush. There are brushes available that can be adapted to variable speed drills.

PREVIOUS CLEANING RESIDUE

Previous cleaning residue sometimes takes a long time to become noticeable. At times it will be evident as soon as the wall surface dries. The residue is usually an organic substance that is trapped in the recessed areas of the hair cell pattern. It is necessary to use special cleaners that actually suspend the organic matter so it can be rinsed off the Pro-Tek easily. Commercial floor wax strippers such as "Johnson Wax Step Off" have worked in the past. The problem areas are scrubbed with a stiff bristled brush along with one of these products, then rinsed with clean water.

To add luster and additional protection, a protective coating of "Pledge Spray Wax" or vinyl luster cleaner can be used.

LCS WRITING SURFACE

CARE AND CLEANING INSTRUCTIONS

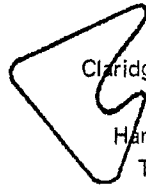
It's called LCS. The porcelain enamel surface is graphically textured to take a positive image from Claridge LCS markers used in our liquid chalk writing system.

This special surface serves as a writing surface, plus it will accept magnetic aids. The image goes on wet, dries quickly, comes off easily with an LCS eraser, any standard all-felt chalkboard eraser, or facial tissue.

LCS marks left on the writing surface for extended periods of time may not erase dry due to the absorptive nature of the marker material. If this condition develops, merely spray the writing surface with Claridge white board cleaner and wipe clean with a soft cloth.

If permanent type markers are used, lipstick, fingernail polish, or other marks are inadvertently placed on the writing surface, they can be removed with typewriter cleaner without damaging the surface. Merely clean, then rinse well with clear water and allow to dry.

Do not use abrasive cleaners on marker board surfaces.

EFFECTIVE WAYS TO CLEAN STAINLESS STEEL

TB-21

CONDITION	CLEANING AGENT	PROCEDURE
Routine cleaning	Liquid soap or detergent Water-soluble household cleaners, diluted as recommended on label	Wipe on and remove with soft cloth or sponge Spray or wipe on and remove with soft cloth or sponge
Spots, fingerprints	Water-soluble household cleaners, full strength Liquid or cream metal polish made for stainless steel, chrome copper or brass	Spray or wipe on, rub spots with soft cloth or sponge As recommended by manufacturer
Stubborn spots, atmospheric discoloration	Liquid or cream metal polish made for stainless steel, chrome copper or brass	As recommended by manufacturer
Mineral deposit or scale from hard water	Commercial lime deposit removers, based on phosphoric and acetic acids 5% acetic acid (white vinegar)	Apply liberally, allow to stand for a few minutes; scrub with coarse toweling or soft bristle brush in direction of grain; rinse well with water
"Rust" spots resulting from exposure to harsh environmental and or chemical conditions.	Appropriate cleaner listed above, plus 150/180 grit emery paper and 3M Scotch Brite pad #7447, fine grade or equivalent	Clean surface as above, then rub stained area lightly with emery paper, polish with Scotch Brite pad Rub only with the grain direction of satin finishes. . . do not use on bright polished or brass surfaces

Always: Scrub and polish with the grain direction of satin finishes.

Remove any cleaning or soap residue from stainless surface with water and wipe dry with clean cloth or paper.

Caution: Avoid cleaning products containing chlorine bleach, hydrochloric or muriatic acid from contacting stainless steel. . . these are frequently found in toilet bowl or tile cleaners and in abrasive scrubbing powders.

Avoid use of steel wool which can leave behind fine particles that will rust on the surface.

Avoid use of abrasive cleaners on bright polish stainless steel or brass surfaces.
